## AN ACT RELATIVE TO HOME OWNERS INSURANCE.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. There shall be a special commission to review the current state of the homeowners'  
2 insurance market. The commission shall study the availability and affordability of property insurance,  
3 the relevant rate-driving factors, the cost of reinsurance and the current use of storm damage prediction  
4 data and shall consider any actuarial methods, principles, standards, models or output ranges that have  
5 the potential for improving the accuracy of or reliability of hurricane loss projection methodology to  
6 provide actuarial guidelines and standards for projection of hurricane losses as well as for a state-run  
7 catastrophic event fund.

8 The commission shall consist of: the house and senate chairs of the joint committee on financial  
9 services or their designees, who shall co-chair the commission; the house minority leader, or his  
10 designee; the senate minority leader, or his designee; 1 member of the house of representatives; 1  
11 member of the senate, both of whom shall represent Cape Cod and another coastal area; the state  
12 treasurer or his designee; the commissioner of insurance or his designee, the attorney general or his  
13 designee; a representative from the Massachusetts Association of Insurance Agents; 2 representative to  
14 be selected by the Reinsurance Association of America; 1 representative from the Center for Insurance  
15 Research; and 1 representative from the Massachusetts Public Interest Research Group. The  
16 commission shall conduct not less than 4 meetings, the first of which shall convene not later than July  
17 21, 2008, and it shall hold at least 1 public hearing on Cape Cod or other coastal.

19 Notwithstanding any general or special law to the contrary, the commissioner shall not approve any rate  
20 filing required under section 5 of chapter 175C of the General Laws until after the commission has filed  
21 its report or October 1, 2008, which ever is earlier.

22 The commission shall file a report of its findings, including any legislative or regulatory  
23 recommendations, with the clerks of the house of representatives and the senate by October 1, 2008.  
24 The joint committee on financial services shall hold a public hearing on these recommendations not  
25 later than November 1, 2008.
