## AN ACT TO ESTABLISH AN ALZHEIMER'S STATE PLAN COMMISSION.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- **Section 1.** Pursuant to section 2 of chapter 111 of the General Laws, the Alzheimer's State Plan
- 2 Commission is established. The Alzheimer's State Plan Commission will consist of the following
- 3 members, including, but not limited to, the Chairpersons of the Joint Committee on Healthcare
- 4 Financing; Elder Affairs; and Children, Families and Persons with Disabilities or their designees, at least 1
- 5 person with Alzheimer's disease; 1 caregiver of a person with Alzheimer's disease; 1 representative of
- 6 the nursing facility industry; 1 representative of the assisted living industry; 1 representative of the adult
- 7 day services industry; 1 representative of the medical care provider community; 1 representative of the
- 8 home care/home health industry; 1 representative from hospice; 1 Alzheimer's disease researcher; and
- 9 1 representative from the Alzheimer's Association Massachusetts/New Hampshire Chapter to be
- 10 appointed by the Governor.
- 11 Additional members are to be the Commissioner of the Department of Public Health, the Secretary of
- 12 the Executive Office of Elder Affairs, the Secretary of the Executive Office of Health and Human Services,
- 13 the Commissioner of the Department of Mental Retardation, the Director of the Office of Medicaid, the
- 14 Secretary of the Executive Office of Public Safety and Security, and the Secretary of the Executive Office
- of Labor and Workforce Development, or their designees.
- 16 Members of the Commission shall serve on a voluntary basis and are not entitled to mileage, per diem,
- 17 subsistence or other forms of compensation.
- 18 Section 2. The Executive Office of Health and Human Services shall convene the Alzheimer's State Plan
- 19 Commission and the Secretary shall serve as the chair.
- 20 Section 3. The Alzheimer's State Plan Commission is directed to assess the current and future impact of
- 21 Alzheimer's disease on residents of the Commonwealth, to examine the existing industries, services and

22 resources addressing the needs of persons with Alzheimer's, their families and caregivers; and to 23 develop a strategy to mobilize a state response. 24 **Section 4.** This report is to include: 25 (1) trends in the Commonwealth's Alzheimer's population and needs, including the changing 26 population with dementia; 27 (2) existing services, resources, and the capacity to serve persons with Alzheimer's and related 28 dementia; and, 29 (3) needed state policies or responses, including but not limited to directions for the clear and 30 coordinated services and supports to persons and families living with Alzheimer's and related 31 disorders and strategies to address any identified gaps in services. 32 33 Section 5. The Alzheimer's State Plan Commission is directed to hold public meetings as needed and utilize technological means, such as webcasts, to generate discussion and gather feedback on the 34 recommendations from persons and families affected by Alzheimer's disease and the general public 35 across the Commonwealth. 36 37 Section 6. The Alzheimer's State Plan Commission is directed to submit a report of its findings and data-38 39 specific recommendations to the Governor, the General Court, the Department of Elder Affairs, the Joint 40 Committee on Children, Families and Persons with Disabilities, and the Joint Committee on Healthcare 41 Financing on the form of a State Alzheimer's Plan no later than February 1, 2010. 42 43 Section 7. The Alzheimer's State Plan Commission shall sunset upon delivery of the State Alzheimer's 44 Plan.
