AN ACT RELATING TO THE FOREST PRODUCTS INDUSTRY.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 *Whereas*, the deferred operation of this act would tend to defeat its purpose, which is forthwith
2 to assist certain businesses drastically affected by certain economic events, therefore, it is hereby
3 declared to be an emergency law, necessary for the immediate preservation of public convenience.

5 SECTION 1: The secretaries of the executive office of economic development and the executive office of
6 energy and environmental affairs are hereby directed to establish the forestry industry economic
7 stimulus program.

9 The forestry industry economic stimulus program shall:

10

11 (a) provide a 100% tax credit with a 10 year carry through for costs and loan interest for landowners who
12 develop a forest viability business plan with a no development covenant approved by the department of
13 conservation and recreation.

14 (b.) provide a 30% tax credit with a 10 year carry through for investments and loan interest for new
15 technology and the modernizing of infrastructure needed in the operation of forestry related industry.

16 (c.) provide a 100% tax credit with a 2 year carry-forward for landowners who develop forest
17 management plans as described in chapter 61 of the Massachusetts General Laws and forest
18 stewardship plans.

19 (d.)provide a tax credit of up to \$50,000, which can be taken over a time period of up to 10 years for
20 individuals starting a business in sawmilling or timber harvesting

21 (1) the executive office of economic development and the department of conservation and
22 recreation shall determine a minimum investment in such a business enterprise as a
23 qualification for the aforementioned tax credit in Section 1(d).

24 (e.)provide a 30% state tax credit with a 10 year carry through for investments in biomass combined
25 heat and power infrastructure and wind energy infrastructure for use on farms, sawmills and harvesters

26 (f.) provide a 3% state tax credit for biomass energy plants with a 30 year carry-forward

27 (g) provide a tax credit of 10 dollars per ton of sustainable forest grown wood chips grown in
28 Massachusetts to biomass plant operators

30 SECTION 2: The Massachusetts Technology Collaborative is directed to establish a contract program with
31 Massachusetts landowners who provide sustainably grown woodchips to biomass energy facilities.

32 (a)under such contracts 5 dollars per ton of wood chips shall be paid by the Massachusetts Technology
33 Collaborative to landowners who have sold sustainably grown wood chips under contract to biomass
34 energy facilities.

35 (1)Only woodchips that are harvested from sustainable forested land shall be eligible for
36 payment

37 (b) monies from the Renewable Energy Trust Fund shall be used to fund the landowners contract
38 program.

41 SECTION 3: The Massachusetts Development Finance Agency is authorized to establish and develop
42 rules and regulations relative to the Forestry Industry Loan Program Fund.

44 In addition thereto the Agency is hereby directed to:

45

46 a) establish a forestry industry loan program fund advisory council, which shall consist of seven
47 members, three members to be appointed by the Massachusetts Development Finance Agency board of
48 directors, experienced in business and finance, who may also be members of the Massachusetts
49 Development Finance Agency board, two members appointed by the commissioner of banks who are

50 experienced in banking or agricultural financing, and may include the commissioner of banks or his
51 designee, two members appointed by the commissioner of the department of conservation and
52 recreation who are experienced in the forestry industry, and may include the commissioner or his
53 designees, said council shall act in an advisory capacity to the Massachusetts Development Finance
54 Agency board in matters relative to the financing of forestry industry loan applications and said council
55 may review and provide technical comments regarding each loan application submitted to the
56 Massachusetts Development Finance Agency board for approval.

57 Said council shall, after providing due notice and opportunity for a hearing, recommend a
58 program to provide sources of funds, including, but not limited to, federal, state or private
59 funding, and issuance of debt or industry assessments for the forestry industry loan program
60 fund. Such recommended program shall, after approval by the board of directors of
61 Massachusetts Development Finance Agency, be filed with the clerks of the senate and the house
62 of representatives and with the commissioner of administration.

63 (b)include within the aforementioned loan program the offering of a low interest loan option to a
64 qualifying businesses within the forestry industry through the use of federal tax exempt bonds.

65 (c) include within the aforementioned loan program a state subsidized interest loan for forestry industry
66 businesses for the acquisition of new equipment in order to maintain viable business practices with the
67 development of new market needs.

68 (1) not more than \$250,000 shall be loaned to any one enterprise in any fiscal year.
