AN ACT RELATIVE TO MOTORCYCLE NOISE REDUCTION.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 7 of chapter 90 of the General Laws, as appearing in the 2006 Official Edition, is
- 2 hereby amended by striking out the sentence contained in lines 51 to 57, inclusive, and inserting in place
- 3 thereof, the following:-
- 4 Every motor vehicle so operated shall be provided with a muffler or other suitable device to prevent
- 5 unnecessary noise; provided, however, that every motorcycle so operated shall be provided with a
- 6 muffler or other suitable device that produces a sound pressure level of not more than eighty-two
- 7 decibels or such lower amount of decibels as the Registrar may prescribe. Sound pressure levels in
- 8 decibels shall be measured on the "A" scale of a sound level meter approved by the Registrar.
- 9 Measurements shall be made of overall vehicle noise at maximum speed at fifty feet in accordance with
- 10 test procedure SAE J192 of the Society of Automotive Engineers, or with such other test procedure for
- 11 measurement of sound pressure levels as the registrar may adopt. Every motor vehicle shall be provided
- 12 with a suitable bell, horn or other means of signaling, with suitable lamps, and with a lock, key or other

- device to prevent such vehicle from being set in motion by unauthorized persons, or otherwise contrary
- to the will of the owner or person in charge thereof.
- 15 SECTION 2. Section 7U of chapter 90 of the General Laws, as so appearing, is hereby amended by
- inserting at the end thereof the following paragraph:-
- Any person cited for a noise violation under this section shall be subject to a fine, in an amount to be
- 18 determined by the registrar. Any person cited for a second or subsequent violation within a one-year
- 19 period shall be prohibited from operating the motorcycle used when committing such violation until
- 20 such time as the motorcycle has passed an inspection and is deemed to comply with acceptable sound
- 21 level standards, as determined by the registrar.
- 22 SECTION 3. There is hereby established a special commission to study the problems associated with
- 23 excessive noise caused by motorcycles. Said commission shall consist of the Registrar of Motor Vehicles
- or his designee, who shall serve as chair; two members of the Senate, one of whom shall be appointed
- 25 by the President of the Senate and one of whom shall be appointed by the Senate Minority Leader; and
- 26 two members of the House of Representatives, one of whom shall be appointed by the Speaker of the
- 27 House of Representatives and one of whom shall be appointed by the House Minority Leader; two
- 28 representatives of the Massachusetts Motorcycle Association; and a representative from a
- 29 Massachusetts-based motorcycle dealership. In conducting its study, the commission shall consider, but
- 30 not be limited to, making a determination as to the best methods for educating motorcycle riders about
- 31 the public nuisance created by excessive sound levels and how to best address this problem. Said
- 32 commission shall report its findings and recommendations for corrective legislation to the House and
- 33 Senate committees on Ways and Means and to the Joint Committee on Public Safety and Homeland
- 34 Security no later than September 1, 2010.
