## AN ACT RELATIVE TO INSURANCE COVERAGE FOR MENTAL HEALTH.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

2	section 22 subsection (g) by inserting, in line 83 after the word "license.", the following:

9	section 47B subsection (g) by inserting, in line 86 after the word "license.", the following:
