AN ACT AMENDING THE HISTORICAL REHABILITATION TAX CREDIT.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Subsection (a) of section 6J of Chapter 62 the General Laws, as appearing in the 2006
2 Official Edition, is hereby amended by inserting after the definition of "Certified rehabilitation" the
3 following definition:-
4 "Gateway municipality", any city or town that according to the United States census has: i) a population
5 greater than 35,000 persons; ii) a median household income below the state average; iii) a per capita
6 income below the state's average; and iv) an educational attainment rate of a city or town below the
7 state's average with a minimum attainment of a bachelor's degree or higher.

8 SECTION 2. Paragraph (1) of subsection (b) of said section 6J of chapter 62 of the General Laws, as so
9 appearing, is hereby amended by striking subparagraph (i) and inserting in place thereof following
10 subparagraph:

11 (i) The commissioner, in consultation with the Massachusetts historical commission, shall authorize
12 annually, January 1, 2010 under this section together with section 38R of chapter 63, an
13 amount not to exceed \$100,000,000. Said amount shall increase to an amount not to

14 exceed \$150,000,000 calendar year 2011; an amount not to exceed \$200,000,000 in
15 calendar year 2012; and continue indefinitely at an amount not to exceed \$200,000,000.

16 The Massachusetts historical commission shall determine the criteria for eligibility for the
17 credit, the criteria to be set forth in regulations promulgated under this section; but, at least
18 25 per cent of the tax credits shall be allowed to projects that contain affordable housing
19 whenever possible and consistent with the criteria. Further, at least 50 per cent of the tax
20 credits shall be allowed to projects in gateway municipalities.

21 SECTION 3. Subsection (a) of section 38R of Chapter 63 the General Laws, as so appearing, is hereby
22 amended by inserting after the definition of "Certified rehabilitation" the following definition:-

23 "Gateway municipality", any city or town that according to the United States census has: i) a population
24 greater than 35,000 persons; ii) a median household income below the state average; iii) a per capita
25 income below the state's average; and iv) an educational attainment rate of a city or town below the
26 state's average with a minimum attainment of a bachelor's degree or higher.

27 SECTION 4. Paragraph (1) of subsection (b) of Section 38R of chapter 63 of the General Laws, as so
28 appearing, is hereby amended by striking subparagraph (i) and inserting the following subparagraph:

29 (i) The commissioner, in consultation with the Massachusetts historical commission, shall authorize
30 annually, beginning January 1, 2010 under this section together with section 6J of chapter
31 62, an amount not to exceed \$100,000,000. Said amount shall increase to an amount not to
32 exceed \$150,000,000 in calendar year 2011 and an amount not to exceed \$200,000,000 in
33 calendar year 2012; and continue indefinitely at an amount not to exceed \$200,000,000.
34 The Massachusetts historical commission shall determine the criteria for eligibility for the
35 credit, the criteria to be set forth in regulations promulgated under this section; but, at least
36 25 per cent of the tax credits shall be allowed to projects that contain affordable housing

37 whenever possible and consistent with the criteria. Further, at least 50 per cent of the tax
38 credits shall be allowed to projects in gateway municipalities.

39 SECTION 5. This act shall take effect on January 1, 2010.
