AN ACT TO STREAMLINE THE PHYSICIAN CREDENTIALING PROCESS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of chapter 176O of the General Laws, as appearing in the 2006 Official
2 Edition, is hereby amended by inserting after the definition of “Health care services” the
3 following new definition:--

4 “Hospital-based physician”, a pathologist, anesthesiologist, radiologist or emergency
5 room physician who practices exclusively within the inpatient or outpatient hospital
6 setting and who provides health care services to a carrier’s insured only as a result of the
7 insured being directed to the hospital inpatient or outpatient setting. This definition may
8 be expanded, after consultation with a statewide advisory committee composed of an
9 equal number of organizations representing providers and those representing health plans
10 including but not limited to a representative from the Massachusetts Medical Society, the
11 Massachusetts Hospital Association, the Massachusetts Association of Health Plans, the
12 Massachusetts Association of Medical Staff Services, and Blue Cross Blue Shield of

13 Massachusetts, by regulation to include additional categories of physicians who practice
14 exclusively within the inpatient or outpatient hospital setting and who provide health care
15 services to a carrier's insured only as a result of the insured being directed to the hospital
16 inpatient or outpatient setting.

18 SECTION 2. Chapter 176O of the General Laws is hereby amended by inserting after section 2
19 the following new sections:--

20 Section 2A. (a) The bureau shall adopt the "Integrated Massachusetts Application
21 for Initial Credentialing/Appointment" and the "Integrated Massachusetts Application for Re-
22 credentialing/Re-Appointment." The bureau, after consultation with a statewide advisory
23 committee composed of an equal number of organizations representing providers and those
24 representing health plans including but not limited to a representative from the Massachusetts
25 Medical Society, the Massachusetts Hospital Association, the Massachusetts Association of
26 Health Plans, the Massachusetts Association of Medical Staff Services, and Blue Cross Blue
27 Shield of Massachusetts shall make any revisions to the statewide uniform physician
28 credentialing application forms that includes but is not limited to applicable accreditation as well
29 as federal and state regulatory changes that will impact such forms. Such forms shall not be
30 applicable in those instances where the carrier has both delegated credentialing to a provider
31 organization and does not require submission of a credentialing application.

32 (b) A carrier and a participating provider shall not use any initial physician
33 credentialing application form other than the uniform initial physician application form or a
34 uniform electronic version of said form. A carrier and a participating provider shall not use any

35 physician re-credentialing application form other than the uniform physician re-credentialing
36 application form or a uniform electronic version of said form. A carrier may require that a
37 physician profile be submitted in addition to the uniform physician recredentialing application
38 form.

39 (c) A carrier shall act upon and complete the credentialing process for 95 percent of
40 complete initial physician credentialing applications submitted by or on behalf of a physician
41 applicant within 30 calendar days of receipt of a complete application. An application shall be
42 considered complete if it contains all of the following elements: --

- 43 (i) the application form is signed and appropriately dated by the physician applicant;
- 44 (ii) all information on the application is submitted in a legible and complete manner
45 and any affirmative answers are accompanied by explanations satisfactory to the
46 carrier;
- 47 (iii) a current curriculum vitae with appropriate required dates;
- 48 (iv) a signed, currently dated Applicant's Authorization to Release Information form;
- 49 (v) copies of the applicant's current licenses in all states in which the physician
50 practices;
- 51 (vi) a copy of the applicant's current Massachusetts controlled substances registration
52 and a copy of the applicant's current federal DEA controlled substance certificate
53 or, if not available, a letter describing prescribing arrangements;
- 54 (vii) a copy of the applicant's current malpractice face sheet coverage statement
55 including amounts and dates of coverage;
- 56 (viii) hospital letter or verification of hospital privileges or alternate pathways;
- 57 (ix) documentation of board certification or alternate pathways;

- 58 (x) documentation of training, if not board certified;
- 59 (xi) there are no affirmative responses on questions related to quality or clinical
60 competence;
- 61 (xii) there are no modifications to the Applicant's Authorization to Release
62 Information Form;
- 63 (xiii) there are no discrepancies between the information submitted by or on behalf of
64 the physician and information received from other sources; and
- 65 (xiv) the appropriate health plan participation agreement, if applicable.
- 66 (d) A carrier shall report to a physician applicant or designee the status of a submitted
67 initial credentialing application within a reasonable timeframe. Said report shall include, but not
68 be limited to, the application receipt date and, if incomplete, an itemization of all missing or
69 incomplete items. A carrier may return an incomplete application to the submitter. A physician
70 applicant or designee shall be responsible for any and all missing or incomplete items.
- 71 (e) A carrier shall notify a physician applicant of the carrier's credentialing
72 committee's decision on an initial credentialing application within four business days of the
73 decision. Said notice shall include the committee's decision and the decision date.
- 74 (f) A physician, other than a primary care provider compensated on a capitated basis,
75 who has been credentialed pursuant to the terms of this section shall be allowed to treat a
76 carrier's insureds and shall be reimbursed by the carrier for covered services provided to a
77 carrier's insureds effective as of the carrier's credentialing committee's decision date. A primary
78 care physician compensated on a capitated basis who has been credentialed pursuant to the terms
79 established in this section shall be allowed to treat a carrier's insureds and shall be reimbursed by

80 the carrier for covered services provided to the carrier's insureds effective no later than the first
81 day of the month following the carrier's credentialing committee's decision date.

82 (g) This section shall not apply to the credentialing and re-credentialing by carriers of
83 psychiatrists or hospital-based physicians.

84 Section 2B. (a) The bureau's accreditation requirements related to credentialing
85 and re-credentialing shall not require a carrier to complete the credentialing or re-credentialing
86 process for hospital-based physicians.

87 (b) Except as provided in paragraph (d), a carrier shall not require a hospital-based
88 physician to complete the credentialing and recredentialing process established pursuant to the
89 bureau's accreditation requirements.

90 (c) A carrier may establish an abbreviated data submission process for hospital-
91 based physicians. Except as provided in paragraph (d) of this section, said process shall be
92 limited to a review of the data elements required to be collected and reviewed pursuant to
93 applicable federal and state regulations as well as national accreditation organization standards.

94 (d) In the event that the carrier determines that there is a need to further review a
95 hospital-based physician's credentials due to quality of care concerns, complaints from insureds,
96 applicable law or other good faith concerns, the carrier may conduct such review as is necessary
97 to make a credentialing or re-credentialing decision.

98 (e) Nothing in this section shall be construed to prohibit a carrier from requiring a
99 physician to submit information or taking other actions necessary for the carrier to comply with
100 the applicable regulations of the board of registration in medicine.

101 (f) The bureau, after consultation with a statewide advisory committee composed of
102 an equal number of organizations representing providers and those representing health plans
103 including but not limited to a representative from the Massachusetts Hospital Association, the
104 Massachusetts Medical Society, the Massachusetts Association of Health Plans, the
105 Massachusetts Association of Medical Staff Services, and Blue Cross and Blue Shield of
106 Massachusetts, shall develop standard criteria and oversight guidelines that may be used by
107 carriers to delegate the credentialing function to providers. Such criteria and oversight guidelines
108 shall meet applicable accreditation standards.

109 SECTION 3. The act shall become effective on October 1, 2010.
