AN ACT RELATIVE TO LICENSING DOCKING PILOTS FOR PUBLIC SAFETY.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	Chapter 103 of Massachusetts General Laws is amended as follows:
2	
3	SECTION 1. Section 1A of Chapter 103 is amended by striking the word "Definition"
4	and inserting the word "Definitions". Two additional definitions are to be added to
5	Section 1A, they are as follows:
6	"Commissioned Harbor Pilot" is any individual that has been granted a commission
7	pursuant to this chapter.
8	"Licensed Docking Pilot" is an individual that has been issued a license pursuant to this
9	chapter.
10	
11	SECTION 2. Section 2 of Chapter 103 is amended by striking the word "two" in the first
12	sentence and inserting the word "three".

14	SECTION 3. Section 3 of Chapter 103 is amended as follows:
15	By striking the word "pilots" in the second sentence and inserting the words
16	"Commissioned Harbor Pilots" and:
17	By adding a new paragraph that states as follows:
18	The Commissioner(s), subject to the approval of the trustees of said society, shall
19	establish rules and regulations for the licensing of "Licensed Docking Pilots" within the
20	Commissioner(s) respective district. Said rules and regulations shall include but not be
21	limited to the qualifications for an individual to be licensed as a "Licensed Docking
22	Pilot" under this Chapter. The Commissioner(s) shall issue licenses to individuals that
23	meet the qualifications required by the rules and regulations that are established pursuant
24	to this chapter. The Commissioner(s) may, upon satisfactory evidence of misconduct or
25	negligence suspend the license of a "Licensed Docking Pilot" until the next meeting of
26	the trustees of said society and may continue the suspension thereafter until the next
27	scheduled meeting of the trustees, but no longer for the same occurrence. At any
28	meeting(s) of the trustees herein described, the trustees may decide to revoke the license
29	of a "Licensed Docking Pilot". If the trustees agree that a license for a docking pilot
30	should be revoked then the Commissioner(s) may do the same after the decision is
31	rendered and before it is revoked.
32	SECTION 4. Section 5 of Chapter 103 is amended by striking the entire section and

33 inserting the following;

34	"Once each calendar quarter, every Commissioned Harbor Pilot and/or Licensed Docking
35	Pilot shall render to the Commissioner(s) of their respective district an accurate account
36	of all vessels navigated or assisted by such individual and all fees received by said
37	individual or on their behalf for services. Any person receiving remuneration for services
38	as a "Commissioned Harbor Pilot" or a "Licensed Docking Pilot", shall remit to the
39	respective Commissioner(s) the following amounts that are received by the individuals
40	charging the fees:
41	
42	(a) For Commissioned Harbor Pilots and Licensed Docking Pilots the amount one and
43	one half per-cent (1 and $1/2$ %) within pilot District One.
44	
45	(b) For Commissioned Harbor Pilots and Licensed Docking Pilots, the amount of four
46	per-cent (4%) in all other pilot districts.
47	
48	If any individual or entity that is subject to this chapter and section shall make a false
49	return he/she or it shall be subject to a penalty of \$50.00 USD).
50	
51	The Trustees of the Boston Marine Society shall from time to time fix the compensation
52	of the Commissioner(s) and their allowance for office rent, clerk hire and incidental
53	expenses. The same shall be paid out of the amounts paid to the Commissioners. Any
54	surplus shall be paid to the Boston Marine Society."

55	SECTION 5. Section 6 of Chapter 103 is amended by striking the word "pilot" in the
56	first sentence and inserting the words "Commissioned Harbor Pilot or Licensed Docking
57	Pilot".
58	
59	SECTION 6. Section 15 of Chapter 103 is amended by striking the words "pilot" in the
60	first sentence both times it appears and inserting the words "Commissioned Harbor Pilot
61	or Licensed Docking Pilot", and by striking the word "pilot" in the second sentence and
62	inserting the word "Commissioned Harbor Pilot or Licensed Docking Pilot".
63	
64	SECTION 7. Section 16 of Chapter 103 stricken in its entirety and the following is
65	inserted in its place:
66	"A Commissioned Harbor Pilot or Licensed Docking Pilot, in case of the decease,
67	insolvency or bankruptcy of a surety upon his/her bond, shall give notice thereof to the
68	Commissioners. In such a case, or whenever a Commissioned Harbor Pilot or Licensed
69	Docking Pilot bond appears to the Commissioners to be insufficient, the individual shall
70	give a new bond."
71	
72	SECTION 8. Section 17 of Chapter 103 is amended by striking the words "pilot" in the
73	first sentence and inserting the words "Commissioned Harbor Pilot or Licensed Docking
74	Pilot".
75	

76	SECTION 9. Section 18 of Chapter 103 is amended by striking the words "pilot" in the
77	first sentence and inserting the words "Commissioned Harbor Pilot or Licensed Docking
78	Pilot".
79	
80	SECTION 10. Section 19 of Chapter 103 is amended by striking the words "pilot" in the
81	first sentence and inserting the words "Commissioned Harbor Pilot or Licensed Docking
82	Pilot" and by inserting after the word "commission" in the same sentence the words "or
83	license".
84	
85	SECTION 11. Section 20 of Chapter 103 stricken in its entirety and the following is
86	inserted in its place:
87	"A Commissioned Harbor Pilot or Licensed Docking Pilot taking charge of a vessel that
88	is beyond the scope of his her commission or license shall be suspended or removed."
89	
90	SECTION 12. Section. 21 of Chapter 103 is amended by striking the words "pilot" in the
91	first sentence and inserting the words "Commissioned Harbor Pilot".
92	
93	SECTION13. Section 35 of Chapter 103 stricken in its entirety and the following is
94	inserted in its place:

96	"(A). If a Commissioned Harbor Pilot offers services or if the same can be obtained
97	within a reasonable time, no person who is not a member of the crew of the vessel shall
98	assume or continue to act as pilot in the charge or the conduct of any vessel subject to
99	compulsory pilotage.

101	(B). If a Commissioned Harbor Pilot or Licensed Docking Pilot offers services or if the
102	same can be obtained within a reasonable time, no person who (a) is not a member of the
103	crew of the vessel; (b) does not hold a commission as a Commissioned Harbor Pilot; or
104	(c) does not hold a license as a Licensed Docking Pilot, shall assist or participate in any
105	maneuver of any vessel subject to compulsory pilotage, using the assistance of tugs or
106	other assist craft.
107	
108	(C). Whoever violates the provisions of this section shall be punished by a fine of not
109	less than five thousand nor more than ten thousand dollars."
110	
111	SECTION 14. Chapter 103 is further amended by adding a new Section that shall be
112	designated as "Section 36". That Section states as follows:
113	"36. Persons Employed in Connection with Tug Assisted Maneuvers.
114	When a vessel subject to compulsory pilotage employs one or more tugs or other assist
115	craft to maneuver, dock, or undock, then any person who directs the assisting vessel(s) in
116	said maneuver, etc. must be either (a) a Commissioned Harbor Pilot or (b) a Licensed
