# The Commonwealth of Massachusetts

In the Year Two Thousand and Nine

## AN ACT PROVIDING FOR THE CREATION OF A SPECIAL COMMISSION RELATIVE TO THE IMPACT ON THE COMMONWEALTH OF MASSACHUSETTS OF THE INTERNATIONAL TRADE AND INVESTMENT AGREEMENTS.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 3 of the General Laws is hereby amended by adding the following section:--

2 Section 69. A permanent special commission is hereby established for the purpose of evaluating  
3 the continuing impacts on state laws and regulations by international trade policy and international  
4 trade agreements, examining proposed international trade agreements, maintaining active  
5 communications with any individual or entity, as the commission determines appropriate, regarding  
6 ongoing developments in international trade agreements and policy; and examining any aspects of  
7 international trade, international economic integration and international trade agreements that the  
8 members of the commission consider appropriate. An "international trade agreement" is defined as any  
9 international trade or investment agreement or treaty, including but not limited to, the North American  
10 Free Trade Agreement (NAFTA), the Central American Free Trade Agreement (CAFTA), and agreements  
11 concluded by the World Trade Organization (WTO).

12 Said Commission shall engage in at least one public hearing annually and shall report on the  
13 economic and sovereignty impacts of international trade agreements on the Commonwealth of  
14 Massachusetts. Such report may include recommendations of support or opposition of revisions in  
15 United States trade policy or commitments, including but not limited to proposed international trade  
16 agreements. This annual report shall be transmitted to the General Court, the Governor, the Attorney

17 General of the Commonwealth of Massachusetts; to federal officials, including the United States Trade  
18 Representative and members of the Massachusetts Congressional delegation.

19 Said commission shall consist of 3 members of the Senate of the General Court, 3 members of the  
20 House of Representatives of the General Court, the Governor or his designee, the Attorney General or  
21 her designee, the Treasurer or his designee, a representative from the Office of International Trade &  
22 Investment, and 9 persons appointed by the Governor, one of whom shall be a representative of  
23 organized labor, one of whom shall represent small business, one of whom shall be a representative  
24 from a human rights organization, one of whom shall represent farmers, one of whom shall be a  
25 representative from an environmental group, one of whom shall be a representative of the  
26 Massachusetts Municipal Association, one of whom shall be engaged in the business of exporting goods  
27 internationally, one of whom shall be a member of a graduate faculty of law, with expertise in issues of  
28 constitutional federalism, of a private university in the commonwealth, and one of whom shall be a  
29 member of a graduate faculty of economics or labor studies of the University of Massachusetts.
