AN ACT RELATIVE TO THE ARCHITECTURAL ACCESS BOARD.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 13A of Chapter 22 of the General Laws, as appearing in the 2002 Official Edition, is
- 2 hereby amended by striking out after the word "disability", in lines 8 through 13 inclusive, the following
- 3 words "Three of the appointive members shall be selected after consultation with advocacy groups in
- 4 behalf of the physically handicapped. The governor, the secretary, and the director shall exercise their
- 5 best efforts to ensure that at least two of the appointive members shall be registered architects licensed
- 6 to practice in the commonwealth," and inserting in place thereof the following words: -
 - Two of the appointive members shall be architects licensed to practice in the Commonwealth.
- 8 One of the appointive members shall be a licensed building inspector. Three of the appointive members
- 9 shall be selected after consultation with advocacy groups on behalf of persons with disabilities.
- 10 SECTION 2. Section 13A of Chapter 22 of the General Laws, as so appearing , is hereby amended by
- striking out after the word "make", in line 37, the words "public buildings accessible to, functional for,
- 12 and safe for use by physically handicapped persons" and inserting in place thereof the following: -
- 13 "buildings, including areas that are not generally in public use pursuant to the Americans with
- 14 Disabilities Act Accessibility Guidelines, 36 CFR section 1191.1, accessible to, functional for, and safe for
- use by persons with disabilities.".
- 16 SECTION 3. Section 13A of Chapter 22 of the General Laws, as so appearing, is hereby amended by
- 17 striking out, in lines 45-46, the words "if the number of parking spaces in any such area is fifteen or
- 18 more."

- inserting after the word "building", in line 154, the following word:- facility.
- 33 SECTION 11. Section 13A of Chapter 22 of the General Laws, as so appearing, is hereby amended by
- inserting after the twentieth paragraph, in line 183, the following paragraph:-
- 35 "Facility", all or any portion of buildings, structures, site improvements, complexes, equipment,
- roads, walks, passageways, parking lots, or other real or personal property, including the site where the
- 37 building, property, structure of equipment is located.
- 38 SECTION 12. Section 13A of Chapter 22 of the General Laws, as so appearing, is hereby amended by
- 39 striking out, in lines 206 and 207 inclusive, the following words, "with a capacity of fifteen or more
- 40 automobiles.".
