AN ACT REGULATING SEX OFFENDER REGISTRATION IN THE 21ST CENTURY.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 178C of Chapter 6 of the General Laws, as appearing in the 2004 Official
2 Edition, is hereby amended by inserting after the definition of “Agency”, the following new
3 definition:-
4 “Electronic alias, address and domain”, any electronic mail, website registrations, messaging and
5 chat service aliases, websites and domains either personally owned and operated or otherwise
6 owned and operated by a third party with the purpose of displaying, soliciting or otherwise
7 posting information, entries and aliases associated with either web-based applications and
8 databases, or aliases used and/or stored on personal computers that may be transmitted for use
9 during any communication.

10 SECTION 2. Section 178D of Chapter 6 of the General Laws, as appearing in the 2004 Official
11 Edition, is hereby amended in subparagraph (a) by inserting after the words “aliases used,” in
12 line 11 the following:- all electronic aliases, addresses and domains

13 SECTION 3. Section 178D of Chapter 6 of the General Laws, as so appearing, is hereby further
14 amended in the second paragraph by inserting after clause (i) in line 37 the following new
15 clause:-

16 (_) the offender’s electronic aliases, addresses and domains;

17 SECTION 4. Section 178E of Chapter 6 of the General Laws, as so appearing, is hereby further
18 amended by inserting after the words “the sex offender’s name,” in line 28 the following:- all
19 electronic aliases, addresses and domains,

21 amended by inserting after the words “failure to do so” in line 56 the following:- , to give notice
22 of a change of electronic alias, address or domain, or the addition of an electronic alias, address
23 or domain and the penalties for failure to do so

54 addition of an electronic alias, address or domain;

56 amended in clause (1) of paragraph (b) by inserting after the words “specific individual by
57 name” in line 26 the following:- , electronic alias, address or domain

58 SECTION 17. Section 178J of Chapter 6 of the General Laws, as so appearing, is hereby further
59 amended in paragraph (c) by inserting after clause (1) the following new clause:-

60 (_) all electronic aliases, addresses and domains;

61 SECTION 18. Section 178K of Chapter 6 of the General Laws, as so appearing, is hereby
62 further amended in subparagraph (c) of paragraph (2) by inserting after clause (i) in line 148 the
63 following new clause:-
