AN ACT RELATIVE TO UNEMPLOYMENT INSURANCE RATES.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1. Paragraph (2) of subsection (i) of section 14 of chapter 151A of the General Laws, as
2 appearing in the 2006 Official Edition, is hereby repealed.

3 SECTION 2. Paragraph (a) of Section 24 of said chapter 151A, as so appearing, is hereby
4 amended by striking out in its entirety said paragraph and inserting in place thereof a new paragraph;

5 (a) Have been paid wages in the base period amounting to at least forty times the weekly benefit rate;
6 provided, however, that for the period beginning on January first, nineteen hundred and ninety-five the
7 individual has been paid wages in at least two quarters of the base period amounting to at least thirty
8 times the weekly benefit rate; provided, further, that said amount shall be increased annually
9 proportionately, rounding to the nearest one hundred dollars, to any increases which have occurred
10 during the prior calendar year in the minimum wage as set forth in section one of chapter one hundred
11 and fifty-one; and, provided further, that any such increase shall be effective beginning on the first
12 Sunday in January.

13 SECTION 3. Section 30 of said chapter 151A, as most recently amended by Section 10 of chapter
14 142 of the Acts of 2003, is hereby amended by striking out subsection (a) in its entirety and inserting in
15 place thereof the following subsection: –

16 (a) Except as provided in subsection (b), the total benefits which an unemployed individual may
17 receive during his benefit year shall be an amount equal to thirty-six percent of his wages in the base
18 period, or an amount equal to thirty times his benefit rate, whichever is less, plus dependency benefits
19 payable under section 29; provided, that if in any month the average state-wide unemployment rate for
20 the prior 6 months, as determined by the United States Department of Labor, is equal to or below 5.1
21 percent, the total benefits which an unemployed individual who then files a claim may receive during his

22 benefit year shall be an amount equal to 36 per cent of his wages in the base period or an amount equal
23 to 26 times his benefit rate, whichever is less, plus dependency benefits payable under said section 29. If
24 such amount includes a fractional part of a dollar, it shall be rounded to the next lower full dollar
25 amount

26 SECTION 4. Section 14G of said chapter 151A is hereby repealed.

28 SECTION 5. Any proceeds accumulated in the Medical Security Trust Fund on the date of
29 dissolution, shall be returned to the employers of the commonwealth on a per employee basis.

31 SECTION 6. Notwithstanding section 14 of chapter 151A of the General Laws, the experience
32 rate of an employer qualifying for it under subsection (b) of said section 14 of said chapter 151A shall be
33 the rate which appears in the column designated "D" for calendar years 2009 and 2010.
