- Section 5. Subsection (2) of paragraph (h) of section 14 of said chapter 151A of the General

- Section 6. Section 24 of said chapter 151A, as so appearing, is hereby amended in subparagraph
- 26 (a) by striking the words "Have been paid wages in the base period amounting to at least thirty
- 27 times the weekly benefit rate" and inserting in place thereof the following:- Have been paid
- 28 wages in at least two quarters of the base period amounting to at least thirty times the weekly
- 29 benefit rate.
