AN ACT TO CREATE A STATEWIDE ASSISTED LIVING FACILITY MASTER PLAN.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. The Secretary of Elder Affairs and the Commissioner of the Department of Housing
- 2 and Community Development are hereby authorized and directed, in conjunction with other
- 3 agencies of the Commonwealth as necessary, to develop a state-wide plan for the development and
- 4 maintenance of assisted living facilities, so-called. Said plan shall include and assessment of
- 5 existing and projected need for such facilities across all income levels, available capacity of existing
- 6 facilities for tenants at all income levels, and projected development of additional capacity in the
- 7 next twenty-five years. Said plan shall also assess any and all means being utilized for payment by
- 8 individuals for residence in assisted living facilities and the projected availability of such means in
- 9 the future for individuals at all income levels from public and private sources, including but not
- 10 limited to, Medicare, Medicaid and private insurers.
- Said plan, based on said assessments, shall included strategies to meet the needs identified in such
- assessments and to facilitate the availability of assisted living facilities for individuals of all income

- 13 levels throughout the Commonwealth, including the development and maintenance of capital
- infrastructure, program services, and public and private sources of financing assisted living
- residence for the citizens of the Commonwealth.
- 16 SECTION 2. Subject to appropriation, not less than two hundred thousand dollars shall be
- expended for the purposes of this Act. Said plan prescribed herein, together with any
- recommendations for legislation necessary to the plan, shall be filed with the clerks of the Senate
- and House of Representatives not later than two years following the passage of this Act.
