AN ACT RELATIVE TO THE REPAIR, REMOVAL AND REPLACEMENT OF DAMS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1.

2 Whereas, there are more than three thousand dams in the Commonwealth, most of which are
3 privately owned or have been abandoned, and many of which no longer serve their original
4 purpose or any other purpose;

5 Whereas, many dams do not comply with the Commonwealth's health and safety standards and
6 therefore pose an immediate threat to public health, safety, welfare, and the environment;

7 Whereas, the removal of dams serving no purpose would eliminate threats posed by those dams
8 and would protect the environment, restore wildlife habitat, enhance fish passage, and eliminate
9 regulatory requirements to register, inspect, and repair useless dams; and

10 Whereas, the deferred operation of this act would tend to defeat its purpose, which is to ensure

11 that all dams in the Commonwealth are promptly inspected and, where appropriate, repaired or
12 removed, therefore it is hereby declared to be an emergency law, necessary for the immediate
13 protection of public health, safety, welfare, and the environment.

14 SECTION 2.

15 (a) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is
16 hereby amended by adding after line 2 the following new definition:- “Abandoned”, a dam that
17 has no identifiable owner or a dam whose owner fails to respond to the owner’s obligations
18 under sections 44 to 48, inclusive.

19 (b) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is
20 hereby amended by adding after line 33 the following new definition: - “High hazard potential
21 dam”, a dam located where failure will likely cause loss of life and serious damage to home(s),
22 industrial or commercial facilities, important public utilities, main highway(s) or railroad(s).

23 (c) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is
24 hereby amended by adding after line 39 the following new definition: - “Significant hazard
25 potential dam”, a dam located where failure may cause loss of life and damage home(s),
26 industrial or commercial facilities, secondary highway(s) or railroad(s) or cause interruption of
27 use or service of relatively important facilities.

28 (d) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is
29 further amended by inserting in line 9 after the word “any” the following words:- “man-made”

30 (e) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is

31 further amended by deleting in lines 10-15 the following words:- “, and which (1) is 25 feet or
32 more in height from the natural bed of the stream or watercourse measured at the downstream toe
33 of the barrier, or from the lowest elevation of the outside limit of the barrier, if it is not across a
34 stream channel or watercourse, to the maximum water storage elevation or (2) has an
35 impounding capacity at maximum water storage elevation of 50 acre feet or more.”

36 (f) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is
37 further amended by inserting in line 17 the after the words “property or safety” the following
38 words:- “or which could cause environmental harm”.

39 (g) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is
40 further amended in line 32 by striking the words “environmental management” and inserting in
41 place thereof the following words:- “conservation and recreation”

42 (h) Section 44 of chapter 253 of the General Laws, as appearing in 2006 official edition, is
43 further amended by adding after the definition of “Owner” the following definition:- “Remove,”
44 or “Removal,” the controlled dismantlement or breaching of a dam to the extent that water is not
45 impounded or diverted by the dam and fish passage is no longer impeded and which is
46 dismantled in compliance with applicable laws and regulations of the Commonwealth.

47 SECTION 3. Dam Removal.

48 (a) Section 46 of said chapter 253 of the General Laws, as appearing in 2006 official edition, is
49 hereby amended in line 14 by inserting after the words “to be unsafe” the following words:- “,
50 threaten the environment, be abandoned, not adequately maintained, or no longer serve its
51 original purpose or any useful purpose as determined by the commissioner of the department”.

52 (b) Section 46 of said chapter 253, as appearing in the 2006 official edition, is further amended
53 in line 19 by striking the words, “safety and property” and inserting in place thereof the
54 following words: “safety, property or the environment”.

55 (c) Section 46 of said chapter 253, as appearing in the 2006 official edition, is further amended
56 in line 22 by inserting after the words “bring the dam into a safe condition” the following
57 words:- “or remove the dam”.

58 (d) Section 46A of said chapter 253, as appearing in the 2006 official edition, is hereby amended
59 in line 1 by inserting after the word “removed” the following word:- “repaired,”

60 (e) Section 46A of said chapter 253, as appearing in the 2006 official edition, is further amended
61 by inserting in line 5 after the words “the owner approving” the following words:- “or
62 removing”

63 (f) Section 46A of said chapter 253, as appearing in the 2006 official edition, is further amended
64 by deleting in line 7 the words “life and property,” and inserting in place thereof the following
65 words, “safety, property or the environment.”

66 (g) Section 47 of said chapter 253, as appearing in the 2006 official edition, is hereby amended
67 by inserting in line 6 after the words “operational condition,” the following words:- “or remove
68 the dam”

69 (h) Section 47 of said chapter 253, as appearing in the 2006 official edition, is further amended
70 by inserting in line 18 after the words “safety or property” the following words:- “or the
71 environment.”

72 SECTION 4.

73 Section 47 of said chapter 253 is hereby amended by striking in lines 22-23 the words “be fined
74 an amount not to exceed \$500 for each offense” and inserting in place thereof the following
75 words:- “shall be punished by a fine of not more than twenty-five thousand dollars if the offense
76 is at a high hazard potential dam or a significant hazard potential dam, as determined by the
77 department, or shall be punished by a fine of not more than five thousand dollars if the offense is
78 at any other dam.”

79 SECTION 5.

80 (a) The commissioner of the department of conservation and recreation, in conjunction with the
81 commissioner of fish and game, the division of fisheries and wildlife and the riverways program
82 shall on or before December 1, 2010, complete a detailed report of all dams deemed
83 jurisdictional under sections 44 through 48, inclusive, of chapter 253 of the General Laws, on
84 public and private property in the Commonwealth. The commissioner of the department of
85 conservation and recreation shall submit the report to the joint committee on environment,
86 natural resources and agriculture and to the senate and house committees on ways and means.
87 This report shall include the following detailed information:

88 (1) A comprehensive list of the person, agency, municipality, or entity that owns and operates
89 every dam, or listed as abandoned if an owner or operator cannot be ascertained, and the location
90 of every dam, where such ownership or operation has been registered with the Office of Dam
91 Safety.

92 (2) A classification of the status of all hazardous dams that pose a threat to public health, safety,

93 welfare, and property or the environment, and when or whether they have been repaired or are in
94 the process of being removed.

95 (3) A comprehensive list of dams that no longer serve their original purpose or any useful
96 purpose and may be removed.

97 (4) A comprehensive list of dams that are abandoned as defined in section 44 of chapter 253 of
98 the General Laws.

99 (5) A comprehensive list of all dams whose existence, condition or operation pose a threat to
100 freshwater animal and plant and resident or migratory fish species habitat or movement.

101 SECTION 6.

102 Nothing in this chapter shall be interpreted in any way to alter or amend any permitting
103 requirements, reporting requirements, allocation procedures, or other requirements set forth in
104 any other provision of the General Laws.
